2. BACKGROUND

The Mangosuthu University of Technology (MUT) is currently in the process of refurbishing its student accommodation on their campuses and this means that before the refurbishments commence proper studies and tests are done to identify defects in on the building, which in this case is the block A residence. Conditional assessments in the building have been carried out to identify the defects in the building and Non-Destructive still need to be done to determine the elements of the structure and ensure that it performs for the intended purpose over time. These tests should include the load test, rebound hammer test, and GPR concrete scanning. This is done so that we can be comfortable with the structural integrity of the building.

SCOPE OF SERVICE

The terms of reference for the investigation (Non-Destructive tests) are as follows:

i) GPR Concrete Scanning – The GPR concrete scanning is required to identify the objects like reinforcement and cables inside the concrete slab. This also help in identifying the existing thickness of the slab. The scanning is required at various areas or spots to confirm the details of the slab at any point.

With the use of GPR, scan all concrete elements to determine the reinforcing/rebar type, size, and location/arrangement for each type of structural element providing concrete. thickness, reinforcing, and void imaging. Reinforcement scanning is to be carried out for both the existing building slabs and columns.

ii) Load Test – This will be required to determine the ability of a structure to carry additional loads, to establish the safety of structures, to validate strengthening, to gain knowledge on the behavior of a structure, and to supplement, validate or refine analytical work models. With the load test the service provider will have to load the slab to measure the deflection. This is to be done as per the SANS 410160-2:2011

iii) Concrete Coring and Strength Testing

Core drilling is to be undertaken at selected locations for each structural system type (10 cylindrical cores).

The cored samples are to be submitted to a SANAS-accredited concrete testing laboratory. and tested for concrete cube strength in accordance with the SANS standards.

The cored locations are to be reinstated and made good following extraction of the test. sample.

iv) Rebound Hummer Test – Like core drilling this is use assessing the compressive strength of concrete
