CERTIFICATE OF INDEPENDENT BID DETERMINATION

2. The bins and benches to have a one-year guarantee and 3 years warrantee.
3. All the bins and benches to be delivered at the exact identified locations around campuses and during the delivery an authorized MUT official will direct the appointed bidder to the exact locations that each bin must be placed.
4. The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.
